PERTINENT INFORMATION

- Monthly minimum food and beverage spending is required of all golf memberships.
 - SINGLE MEMBERS** ~ \$40.00 for November
\$75.00 for April through October
 - FAMILY MEMBERS** ~ \$60.00 for November
\$115.00 for April through October

Restaurant sales tax and gratuities, Snack Shack, Cart, and/or Pool spending do not count toward the monthly minimum.
- The current Initiation Fee is \$3,000.00. *(Initiation fee has been temporarily waived for new members)* **Initiation fee payment is required to be eligible for all senior discounts and/or membership tenure benefits.**
- Dues payment options:
 1. Payment in full by 11/15/18 (Entitles member to 5 Guest Greens Fee passes); **or**
 2. Payment of the balance due (dues less deposit) in full by 2/15/19, without interest fee; **or**
 3. Installment plan of twelve-monthly payments, beginning with November, plus a monthly interest fee equal to 1% of the total annual dues, (November, December and January interest fees are waived).
- *Members must be current in all payment obligations to use the Golf Course, Clubhouse, Driving Range, or Pool Facilities.* A 2% per month service charge will be imposed on all delinquent charges.

***2019 SENIOR STOCKHOLDER MEMBERSHIPS** – 20 year continuous member, 10 year stockholder and over the age of 65 by 4/1/19.

****2019 SENIOR MEMBER MEMBERSHIPS** – 20 year continuous member and over the age of 65 by 4/1/19.

*****NON-RESIDENT OUT OF STATE MEMBERSHIPS** – must be fulltime resident of a state other than NY • facilities only available during membership month(s) (not able to be a guest) • dues and food / beverage minimum required to be paid in advance • not able to receive guest passes or membership discounts • other restrictions apply, please contact Club Manager for full details.

SENIOR STOCKHOLDER AND SENIOR MEMBER DUES ARE REQUIRED TO BE PAID IN FULL BY 2/15/19

Note: Any membership eligible for reduced dues must have paid dues for the full ten or twenty years respectively, before becoming eligible. In categories #3, #5, #10, and #11, memberships established prior to November 1, 1992, require ten years in good standing of continuous full dues payments. In categories #3, #5, #10, and #11, memberships established after December 31, 2006 require the member to attain the age of 72 prior to April 1, of any year to be eligible for senior discounts. **Memberships eligible for reduced dues must pay their dues in full by February 15 to maintain their eligibility.**
